

Fort Hayes Metropolitan Education Center Dress Code

As a member of the Fort Hayes Career Center, our students are expected to maintain professional expectations **at all times**. For this reason, clothing that reflects a professional mindset is required for all Fort Hayes Career Center students **while on our campus**. Students who do not dress appropriately will be required to contact a parent and change clothing. Repeat offenders will receive consequences for insubordination.

The following are **not permitted**:

- Halter tops, bare midriffs, see-through blouses, tank tops, tube tops, sleeveless muscle-type shirts
- Shorts [long slacks, skirts, pants, and Capri pants* below calf/above ankle are acceptable; skirt hems are to be at the extended fingertips when standing; culottes/skorts are classified as shorts and are not acceptable; Bermuda's and long baggy shorts are not classified as Capri pants and are not permitted]
- Bare feet, slides, nor flip-flops (shoes must have a back strap around the ankle)
- "Head rags," handkerchiefs as a head cover, bandannas, sweat bands
- Wearing outdoor clothing in the classrooms, etc. (examples: coats, hats, scarves, gloves, inappropriate head coverings)
- Pajamas (or any bedroom attire including to blankets, slippers, or snuggles)
- Clothing/accessories that may suggest "street" or "gang"-related activities
- Clothing/accessories that advertise alcohol, drugs, tobacco, profanity, or negative social statements
- "The baggy pants look" that exposes underwear/buttocks
- Jeans must be clean, neat, and free of excessive tears. Jeans with tears (shredded jeans) should not be excessive and tears with skin exposure should not fall above the knee
- Jewelry**, metal, pins with protruding attachments or spikes (will be considered unsafe for the person wearing or for others)
- Articles of attire or manner of dress that may be deemed disruptive or inappropriate or unsafe (e.g., micro mini-skirts with tights worn under, leggings worn as pants, adornments attached to clothing)
- Sunglasses, goggles, and hats are not to be worn in school buildings

***Note:** Capri pants will be defined by retail store photos specifically noting Capri pants. Capri's must fit the contour of the leg. Long baggy shorts (whether pulled down or not) are not Capri pants. **Two, three, four finger ring jewelry types ("brass knuckles") are classified as a weapon in the Columbus City Schools.

STUDENT EMAIL ACCESS

Beginning Monday, April 6, 2020,
COLUMBUS CITY SCHOOLS
will be providing each student with
their **own** school email address.

Student email addresses are in the format of
studentIDnumber@columbus.k12.oh.us
(for example, 12345678@columbus.k12.oh.us).

Students will use the same password that they use to log in to district computers at school. Students can access their email account from any device by visiting ccsoffice.org.


Students will be able to use their new email address to connect with their teachers, principals, and school support staff about online assignments, coursework, and school-related activities.

Students are only permitted to send or receive internal email messages. This means that they are only allowed to send and receive messages from other email addresses that end with "@columbus.k12.oh.us". There are a number of exceptions including Google Classroom, Webex video chats, and other educational resources and institutions.

The new student email addresses are governed by Board Policy 7540.03 - Student Education Technology Acceptable Use and Safety.

HOW TO ACCESS STUDENT EMAIL

1. From any device, visit ccsoffice.org.
2. For the username, enter your student email address (example: 12345678@columbus.k12.oh.us).
3. For the password, enter the same password that you use to log in to a computer at school.
4. Contact your school principal or the IT Help Desk (614-365-8425) with any questions or login problems.
5. Note: If you are using a shared or public computer, always remember to log out of your email account before closing your browser or leaving the computer.

Is Your Parent Portal Account Activated? Stay engaged in your child's education by setting up and signing into the Columbus City Schools Parent Portal. Through the Parent Portal, you'll be able to securely access valuable information on your student(s):

- Grades and Course Schedules
- Daily Attendance
- Missed Assignments
- Paperless Applications for: School Choice, Summer School, and Career Tech
- Update Contact Information**
- Pay Fees

****The most updated contact information for your child is needed for the District and its schools to communicate with your family via phone, text, and email. It's very important to update your child's contact information every year, and now it's much easier through the Parent Portal.**

Need to update your contact information? It can all be updated online through the Annual Update in the Portal. This includes emergency contacts, phone numbers, and email addresses. Columbus City Schools communicates information about School Choice Lottery, Career Tech, Summer School, and other pertinent announcements via auto-dialers and email contacts.

Do you have an address change? Parents and Guardians can now update their home address and make a request to change their students' school of enrollment through the Annual Update.

Important Annual Forms are also completed online through the Annual Update in the Portal. This includes acknowledgements such as Emergency Contact Information, Consent for Release of Student Information, Internet Acceptable Use, FERPA Rights, and the Compact Form.

Annual Updates will be processed promptly, and parents will receive a confirmation email when their update is completed.

NEED HELP GETTING CONNECTED? Each parent/guardian has their own personalized Activation Code.

ACTIVATING THE PARENT PORTAL IS EASY.

1. Go to our website at www.ccschools.us and click on the Students & Families tab.
2. Click on the **PARENT PORTAL** box at the bottom of the page.
3. Click on the button that says **NEW USER ACTIVATION**.
4. Enter your **ACTIVATION CODE** (contact your school to obtain one if needed). *We know it's long - that helps keep the data secure - so type carefully.* Once the code has been activated, it can't be used again.
5. Follow the prompts to set up your username/password and to add a recovery email address.
6. If you've forgotten your username/password, click on **EXISTING USER** in the Portal, then click **FORGOT USERNAME/PASSWORD**, and the information will be sent to the email used to set up the account. If you no longer have access to the email you used when setting up the account, **please send a picture ID and your student's name and date of birth to parentportalaccess@columbus.k12.oh.us.**
