### THE ROLE OF THE FACILITIES TASK FORCE

COMMUNITY-LED TASK FORCE SUPPORTED BY DISTRICT STAFF WHO RECOMMENDED PROCESS FOR SCREENING BASED ON NATIONAL BEST-PRACTICE, LOCAL HISTORICAL WORK, AND SUBJECT-MATTER EXPERTISE.

REVIEW DATA AND MAKE RECOMMENDATIONS ON SCHOOLS AND ADMINISTRATIVE BUILDINGS FOR CLOSING OR CHANGING ATTENDANCE BOUNDARIES AND/OR GRADE CONFIGURATIONS.

PROVIDE RECOMMENDATIONS THAT HAVE A **STATEMENT OF RATIONALE**.

RECOMMENDATIONS WILL BE BASED ON OVERALL BALANCE AND **OBJECTIVITY OF FACTORS LISTED IN BOARD POLICY 7105**.

ISSUE DRAFT REPORT TO THE BOARD OF EDUCATION BY THE END OF AUGUST. **FINAL REPORT BY OCTOBER**.

#### **COMMUNITY QUESTIONS/CONCERNS:**

- Minimal Community Feedback
- Service to ESL students: A new English-as-a-Second-Language classroom will likely need to be established at Maize, which would also relieve pressure on current ESL classroom at North Linden.

## COMMUNITY QUESTIONS/CONCERNS FROM COLUMBUS NORTH INTERNATIONAL/COLUMBUS GLOBAL ACADEMY:

- Full Capacity: Can Brookhaven site really accommodate both Columbus International High School and Columbus Global Academy?
- Lost Identity: Some staff at Columbus North International expressed concern about identity of school disappearing after co-location with Columbus Global Academy and ESL offices.
- International Athletics: Are athletic facilities at Brookhaven site up-to-date and appropriate?

#### COMMUNITY QUESTIONS/CONCERNS FROM DOMINION, CSIA, ECOLE KENWOOD, AND HUBBARD:

- Overall Positive Feedback
- Middle School Athletics: Continued concerns about relationship with Bishop Watterson on use of fields.
- Dominion Improvements: Recouping PTO investments in the auditorium and sound system at Dominion.
- Repairs at North High School: Will condition of the facility be addressed prior to their move?
- Building Future: What will happen to the Dominion site?
- Specific Positives: Remaining in neighborhood; Unique outdoor space; Space for STEAM learning;
   Broadened access to curriculum and immersion program.
- Take time to plan program.....

#### **COMMUNITY QUESTIONS/CONCERNS:**

- History/Legacy: Marion-Franklin High School is central to community identity; What would happen to the trophies? Which mascot will be used?
- Neighborhood Growth: Open neighborhoods around Marion-Franklin are primed for growth.
- School Site/Outdoor Space: Room for additional construction on Marion-Franklin site; Marion-Franklin has
  everything on site for athletics and event parking.
- School Site/Indoor Space: "Will everybody fit in both buildings?"; Marion-Franklin has a large band; If combined, is there enough space for classes/practices inside South High School.
- School Site/Service: Both groups noted continuation of Nationwide Children's Clinic inside school.

#### **COMMUNITY QUESTIONS/CONCERNS: (CONTINUED)**

- Safety Concern: How would District address long-standing South Side rivalry?
- Added Transportation: How will the further distance affect bus routes, pickup times?
   (Distance between South and Marion-Franklin is approximately 3.1 miles)
- Student Feedback: Worried about distance from younger siblings, requirements on uniforms (South has uniform policy), and future of beloved teachers.
- Staff Feedback: South staff feels the 7-12 model is working, allows for vertical integration of curriculum, provides opportunity for advanced student classwork.



## COMMUNITY QUESTIONS/CONCERNS FROM SIEBERT ELEMENTARY:

- High Transfer In: Staff feels Siebert Elementary is a "choice school."
- Test Scores: Belief that Siebert is higher performing than other South Side elementary schools.
- Room to Accommodate: Is there space for the students who attend Siebert to attend other South Side elementary schools?
- Building Future: Fear that District is vacating property to sell to developer and that closure will add to gentrification of community.

#### COMMUNITY QUESTIONS/CONCERNS:

- History/Legacy: Linden-McKinley is central to community identity; Families have legacies of graduating from both of these schools; What would happen to the community traditions associated with each school; "Please don't change the name."
- Safety Concern: Does the Task Force/District have a realistic perspective on safety challenges?
- Student Support: Will East have same trauma-informed supports as provided at Linden-McKinley?

#### **COMMUNITY QUESTIONS/CONCERNS: (CONTINUED)**

- East Utilization vs Linden-McKinley Stabilization: Concern that negative impacts to Linden-McKinley because of under-utilization at East High School; Staff recognizes stabilization in staffing and building leadership which would be impacted by change.
- Distance from Linden: Student concern about distance of students who live in Linden area and how they
  would participate in school activities; distance away from younger siblings; inability to walk to school.
  (Driving distance between Linden-McKinley and East is approximately 5 miles)
- Merging Academics: How would students coming through Linden pathway catch up with Health Sciences Academy students from current East pathway?
- Community Planning: Would change at Linden-McKinley impact City's revitalization efforts in Linden?

## COMMUNITY QUESTIONS/CONCERNS FROM MIFFLIN MIDDLE AND MEDINA MIDDLE:

- Academics: Staff at Mifflin Middle School were concerned about impact to academic progress.
- Previous Conversations: "We have done everything you have asked us to do, so why close us?"
- Community Partners: Strong alignment at Mifflin Middle to academic, non-academic support.
- School Site/Land: More open land on the Mifflin Middle site with opportunity to rebuild.
- Distance: How will the move affect transportation?
   (Driving distance between Mifflin Middle and Medina Middle is approximately 3.5 miles)

# SCHOOL SITE ALTERNATIVE SCENARIOS

RECOMMENDATION 4

#### ADJUST FEEDER PATTERN

#### **ALTERNATIVE PROPOSAL:**

Instead of converting Marion-Franklin, convert South High School into a middle school. Marion-Franklin instead becomes the south side high school.

#### **POINTS TO CONSIDER**

Larger site with more athletic facilities, additional parking, room for development.

#### **ALTERNATIVE PROPOSAL:**

Move Buckeye Middle School to co-locate at Marion-Franklin High School. Close Buckeye building.

- Requires creation of two separate programs: 6-8 middle school AND 9-12 high school, with separate administration, programming and service.
- Recommend additional planning year for implementation (2020-2021 School Year).

#### **ALTERNATIVE PROPOSAL:**

 Convert South 7-12 into two separate programs: South Middle School (6-8) and South High School (9-12); Move Fairwood Elementary to East feeder pattern; Move Grade 6 from K-6 feeder elementary schools; Close Siebert Elementary.

- Requires creation of two separate programs: 6-8 middle school AND 9-12 high school, with separate administration, programming and service. Provides middle school experience in South feeder.
- Recommend additional planning year for implementation (2020-2021 School Year).
- Move of Fairwood increases utilization at Champion Middle School and East High School.

#### **ALTERNATIVE PROPOSAL:**

Close Siebert Elementary (if no changes to South High School feeder).

- Reassign students to Stewart Elementary and Southwood Elementary.
- Would consider phasing-out closure (example: elimination of Kindergarten, no new lottery, no new neighborhood student assignment starting next year)

#### **ALTERNATIVE PROPOSAL:**

 Convert Linden-McKinley 7-12 into two separate programs: Linden-McKinley Middle School (6-8) and Linden-McKinley High School (9-12); Move Grade 6 from K-6 feeder elementary schools. Maintain Mifflin Middle and Medina Middle as currently operating (no merging or closure).

- Requires creation of two separate programs: 6-8 middle school AND 9-12 high school, with separate administration, programming and service. Provides middle school experience in Linden-McKinley feeder.
- Recommend additional planning year for implementation (2020-2021 School Year).
- Increases utilization at Linden-McKinley site. Creates space at elementary level for Pre-K and other student support services.

#### **ALTERNATIVE PROPOSAL:**

- Redraw Linden-McKinley feeder attendance boundaries (North: Weber Road; South: I-670; West: I-71;
   East: Sunbury Road)
- Reopen Linmoor Middle School; Build a new Linden-McKinley High School on Linmoor site; Sell current Linden-McKinley High School; reopen Hudson Elementary (Lexington Ave).

- Creates a "campus environment" with elementary, middle, and high school on same site.
- Expands number of students residing in Linden-McKinley feeder zone.
- Requires funding/bond issue.



#### **ALTERNATIVE PROPOSAL:**

Move Eastmoor Academy to co-locate with East High School.

#### POINTS TO CONSIDER

 Co-location of two programs would exceed current capacity at East High School, which would reduce number of students who could lottery into Eastmoor.

#### **ALTERNATIVE PROPOSAL:**

Move Columbus Alternative High School to North High School.

- Still leaves unaddressed over-utilization at Dominion Middle School.
- Creates capacity concerns when moving Grades 7-12 from Columbus North International to former Brookhaven site.



#### **ALTERNATIVE PROPOSAL:**

Move Columbus Alternative High School to East High School.

- Co-location would not be possible because of building capacity.
- Closure of East High School would impact investment/partnerships in Health Sciences Academies.



#### **ALTERNATIVE PROPOSAL:**

Move Columbus Alternative High School to Linden-McKinley High School.

- Co-location would not be possible because of building capacity.
- Closure of Linden-McKinley would impact entire feeder pattern, with no middle or high school assigned for the Linden community.

#### **ALTERNATIVE PROPOSAL:**

- Convert Beechcroft High School into a middle school and move Woodward Park/Woodward Park @
  Walden to new Beechcroft Middle School.
- Reassign Beechcroft High School feeder to Northland High School.
- Convert Woodward Park @ Walden into Pre-K/Early Childhood Education Center.

- Closure would significantly impact student assignment at Northland High School and Mifflin High School.
- Eliminates number of student transitions between K-3, 4-5, 6, 7-8.
- Requires further long-term study which may be better addressed through FMP/new construction.

ALTERNATIVE SCENARIO 3	Convert South into separate South Middle School (6-8) and South High School (9-12)
ALTERNATIVE SCENARIO 4	Close Siebert Elementary
ALTERNATIVE SCENARIO 5	Convert Linden-McKinley into separate Linden-McKinley Middle School (6-8) and Linden-McKinley High School (9-12)
ALTERNATIVE SCENARIO 6	Redraw Linden-McKinley feeder; Reopen Linmoor Middle and Hudson Elem; Build new Linden-McKinley; Sell current Linden-McKinley High School
ALTERNATIVE SCENARIO 7	Move Eastmoor Academy to co-locate with East High School
