

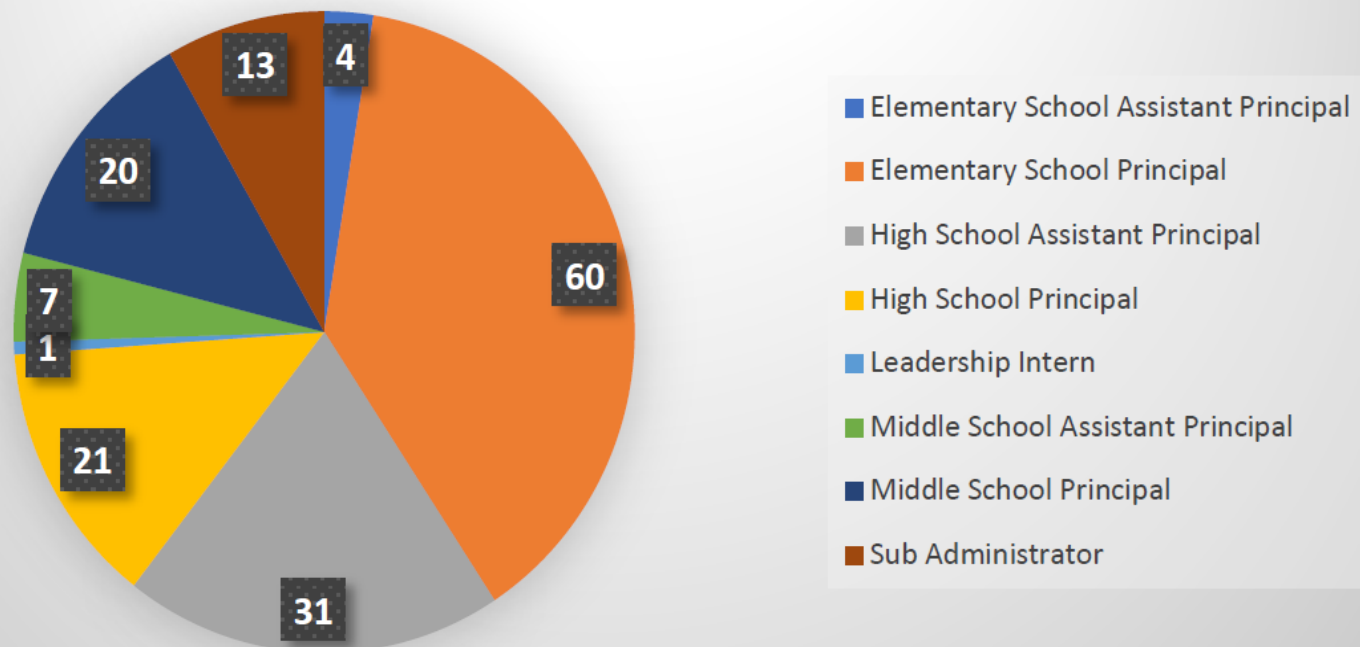

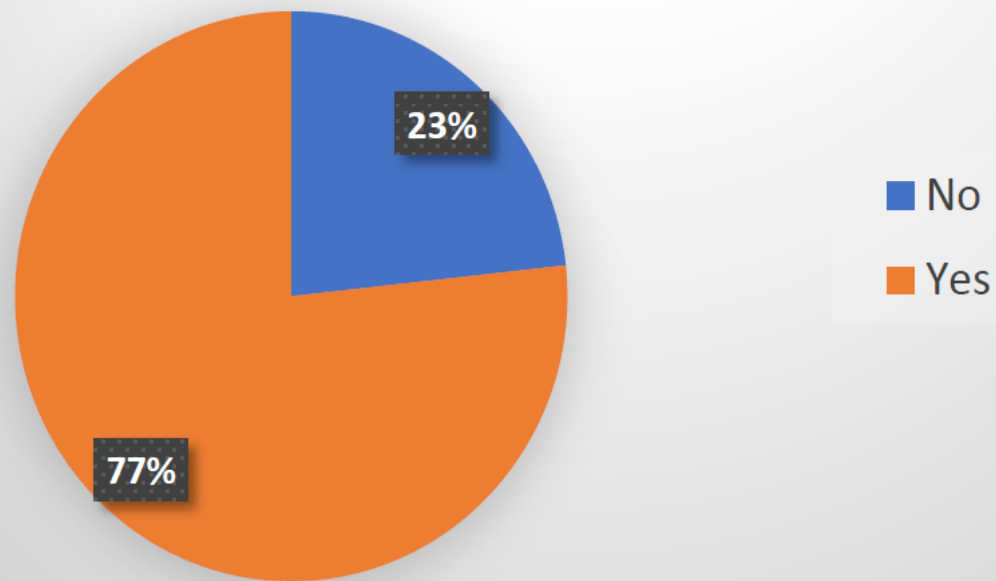

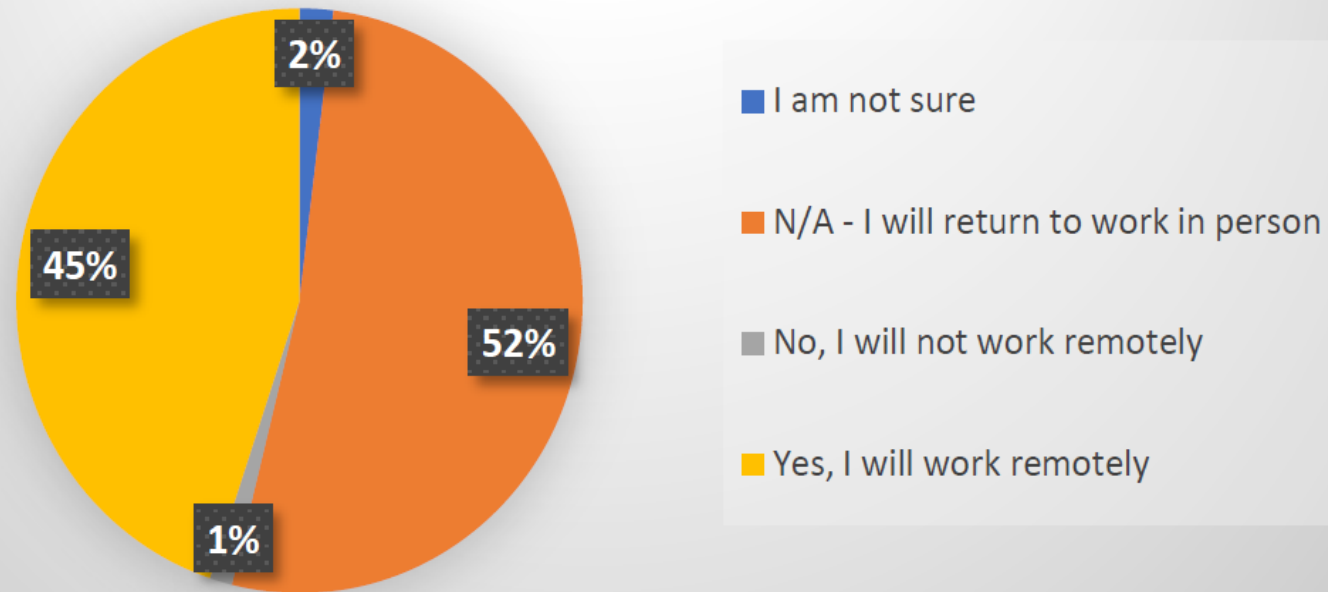
What is your primary role with CCS? Total Responses: 157

I think a hybrid model of both in-person and online learning would be appropriate, however, accommodations must be made for families that do not have access to childcare or are uncomfortable with their child being home alone in the event that family members are required to return to work. The district may want to leverage partnerships with recreation and parks, the faith-based community, the Columbus Metropolitan Library, and Columbus Association for Performing Arts to provide out of school locations where families can have their children report to complete online work with access to wi-fi and Chromebooks, receive nutritious meals and receive socio-emotional programming. These community based off-site locations can be assigned based on geographic location, but attendance would be offered on a volunteer basis as an option for families. Support from ADAMH and other mental health service providers could be implemented to provide meaningful and research-based socio-emotional and ADOS prevention-based supports while students attend these off-site locations. CCS staff could be allocated to manage and document attendance and ensure safety precautions and social distancing measures at these locations. Contracted cleaning services would also be needed at each location around the city.	1

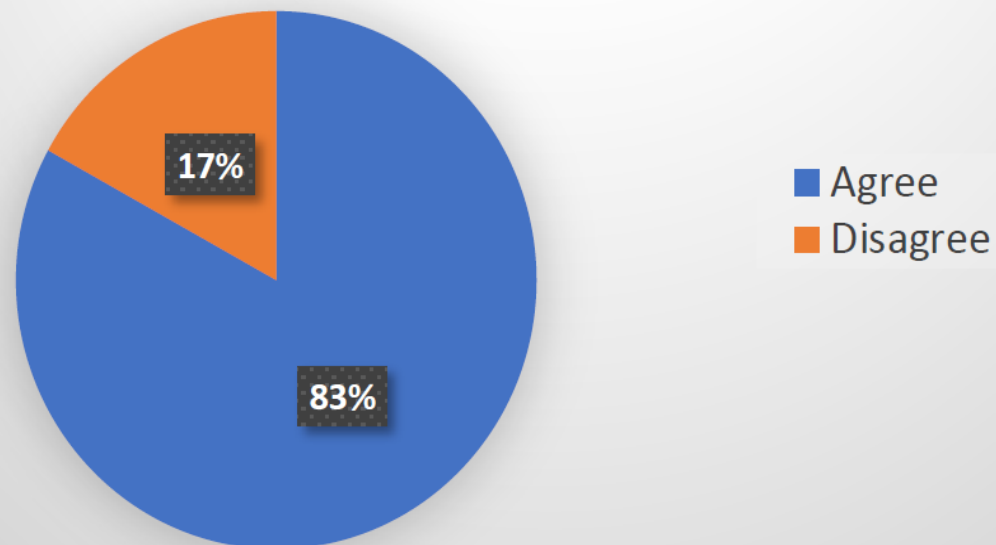

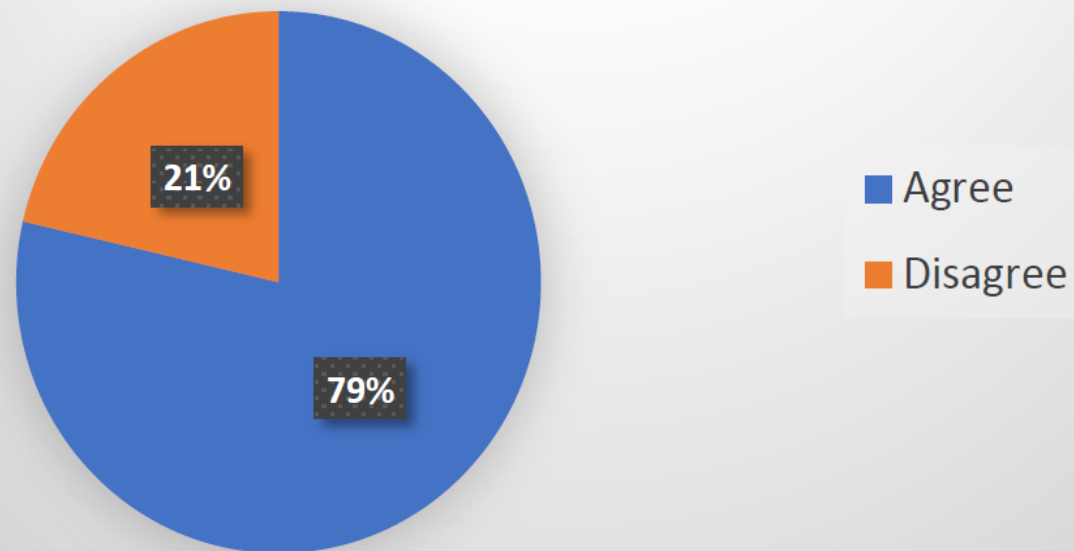
