Feedback from Community Events (to date)

There have been 4 community engagements so far.

These have produced a total of 422 pieces of feedback from the community including:

- 45 handwritten comments, and
- 377 survey responses
 - From 13 (Scenario 4) to 131 (Scenario 3B)

There have been 45 handwritten responses so far.

Side A

Preserving School Identity

Many responses express concern about the potential loss of school identity and community if schools are consolidated or closed. They worry about the impact on students, staff, and the wider community, and question what will happen to school traditions, sports teams, and other aspects of school culture. Some suggest that certain schools should be left alone due to their historic status.

Common ground

Student Well-being and Achievement

Despite their differing views, both sides agree on the importance of student well-being and achievement. They express a desire for decisions to be made in the best interests of students, whether that means preserving existing school communities or creating new opportunities through consolidation. They also emphasize the need for a safe and supportive learning environment.

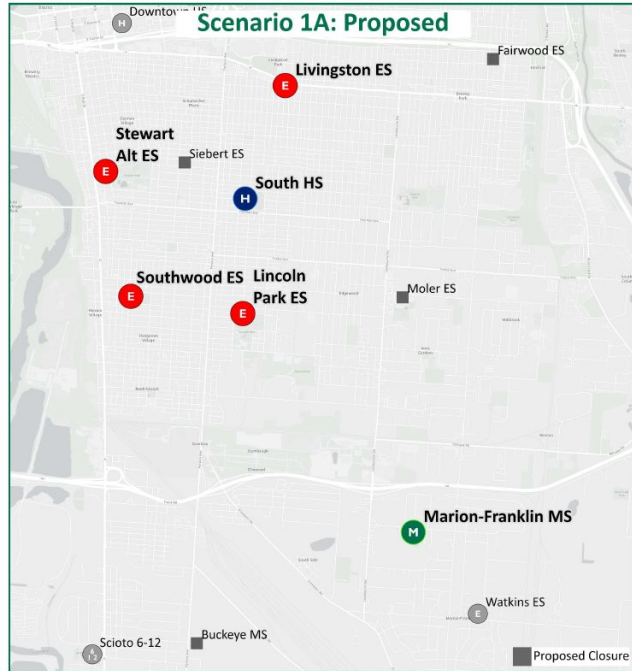
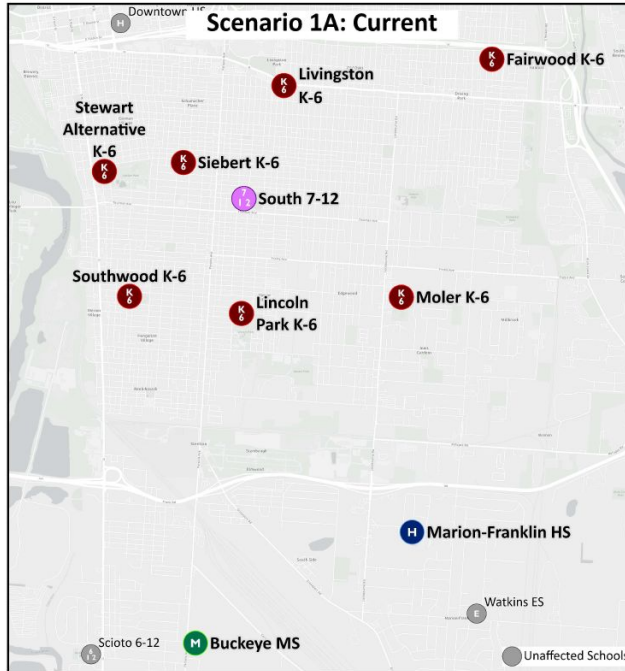

Improving Educational Opportunities

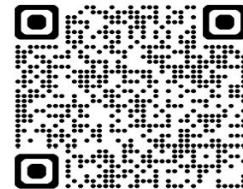

Initial Feedback on 1A

There have been 50 responses about this scenario.

Side A

Opposition to School Closures

Many respondents are against the proposed scenario 1a due to concerns about the impact on the community, particularly the ESL community. They worry about the loss of jobs, increased transportation costs, and the potential for increased conflict among students from rival schools. They also express concern about the lack of transparency and community input in the decision-making process.

Concern for Student Well-being

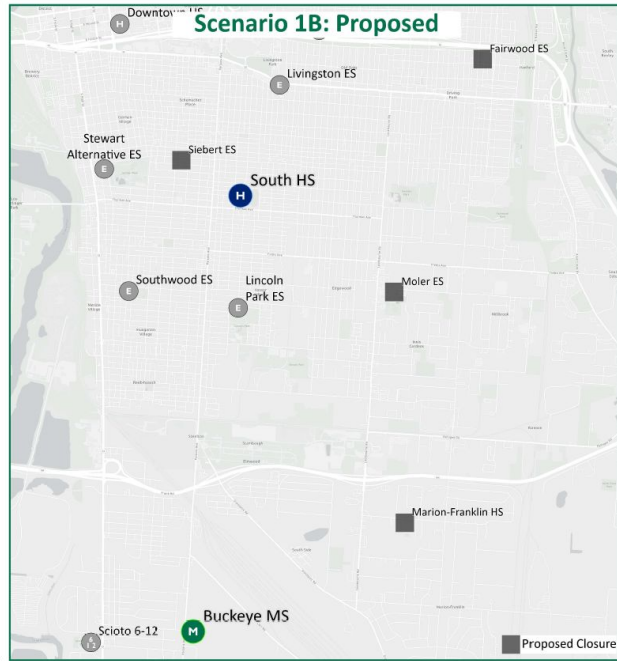
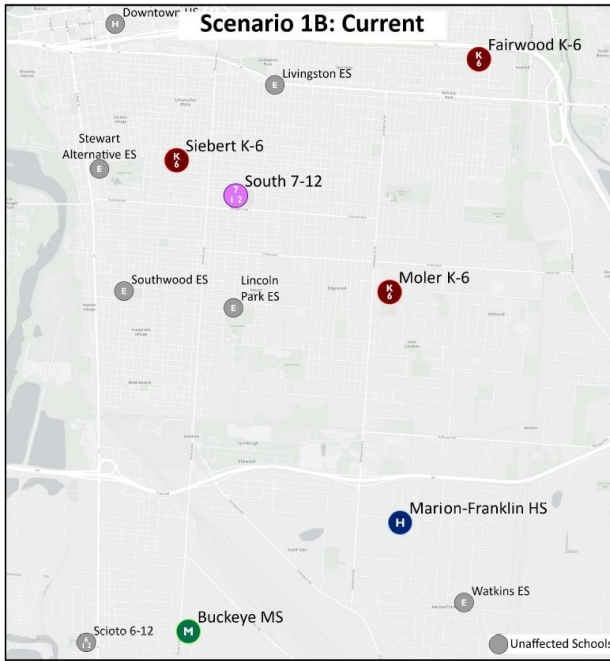

Support for School Reorganization

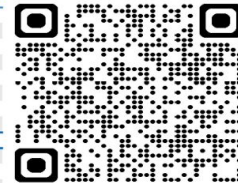

Initial Feedback on 1B

There have been 16 responses about this scenario.

Side A

Opposition to School Closures

Many respondents are opposed to the proposed school closures, particularly Siebert and Marion-Franklin. They argue that these schools are performing well, serving a significant portion of the ESL community, and are chosen by families for their children. They express concerns about the impact on program continuity, community, and student safety. They also question the motives behind the decision, suggesting it is driven by real estate opportunities rather than the best interests of the students.

Common ground

Need for Transparency

A common ground among the respondents is the need for transparency in the decision-making process. They want to understand the rationale behind the proposed school closures and consolidations. They believe that any recommendations should be accompanied by a clear statement of rationale, as stipulated by the Community Facilities Task Force.

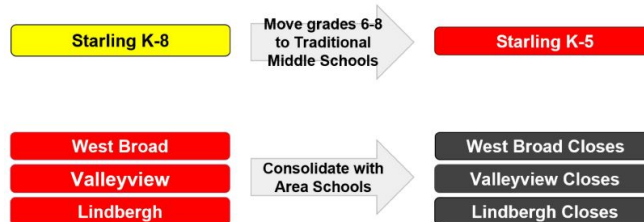
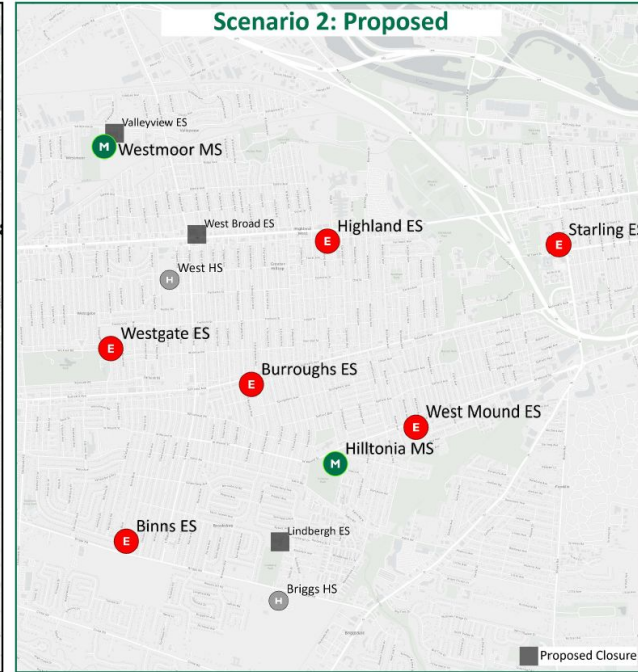
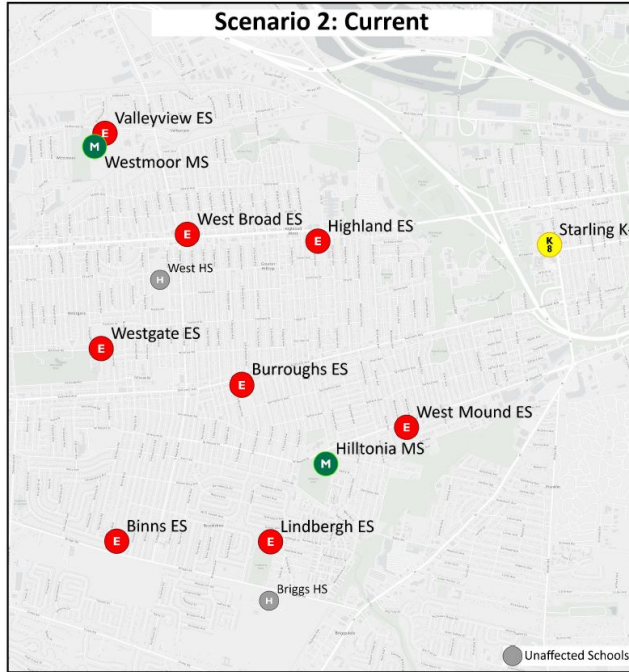

Concerns about Overcrowding

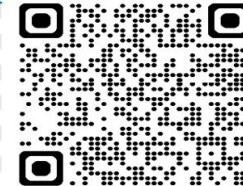

Initial Feedback on 2

There have been 20 responses about this scenario.

Side A

Opposition to School Closures

Several respondents expressed concern about the proposed scenario, particularly the closure of local schools. They highlighted the potential negative impacts on students, such as longer travel times and less options for schooling. They also questioned the fiscal responsibility of closing schools that have recently undergone renovations and serve vulnerable student populations.

Concern for Student Welfare

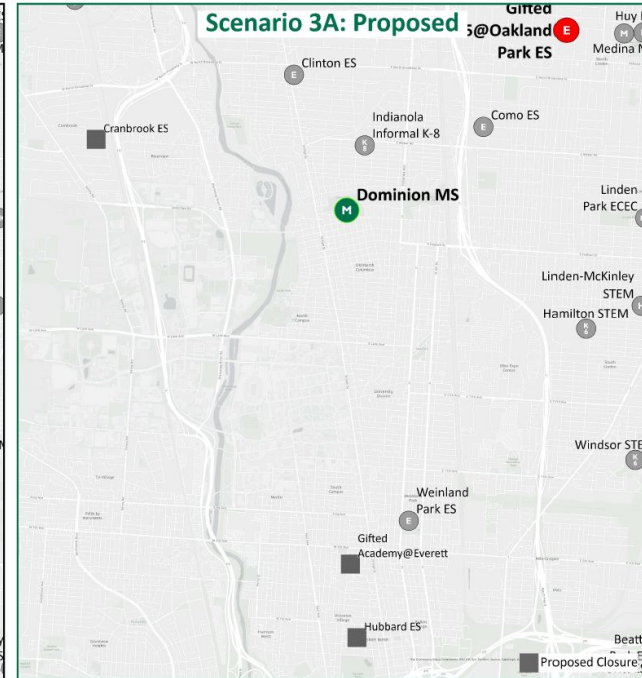
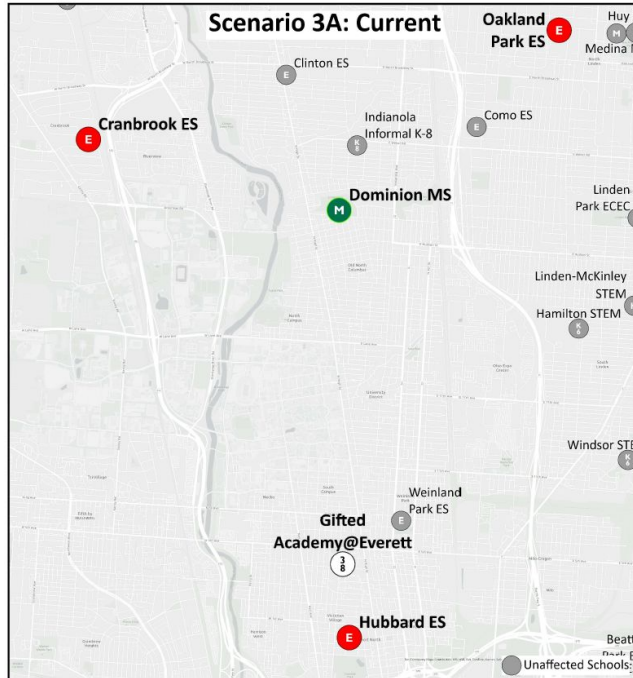

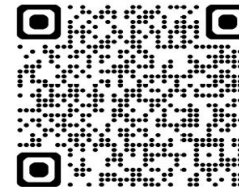
There have been 60 responses about this scenario.

Initial Feedback on 3B

There have been 131 responses about this scenario.

Side A

Opposition to School Closures

Many respondents express strong opposition to the proposed scenario 3b, which involves closing several schools. They cite concerns about the impact on students, teachers, and the community, as well as the potential for increased transportation issues. Some also question the logic behind the decision, suggesting that the schools slated for closure are performing well and serve important roles in their communities.

Concern for Student Welfare

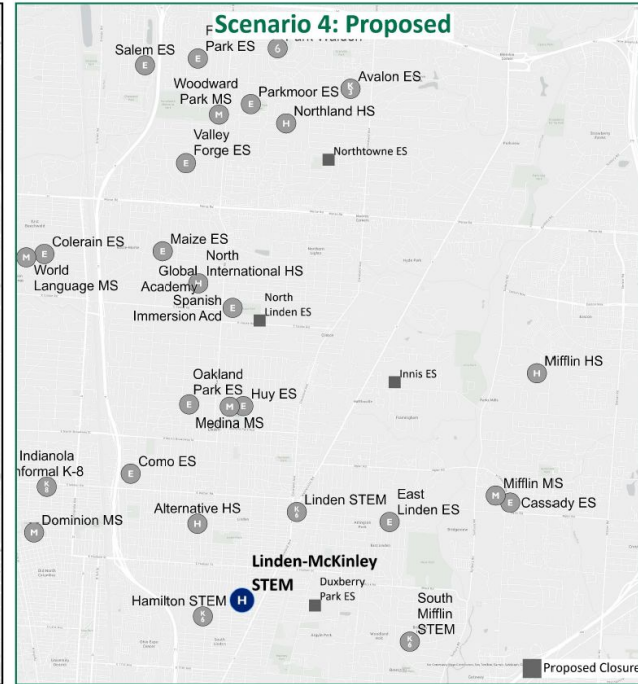
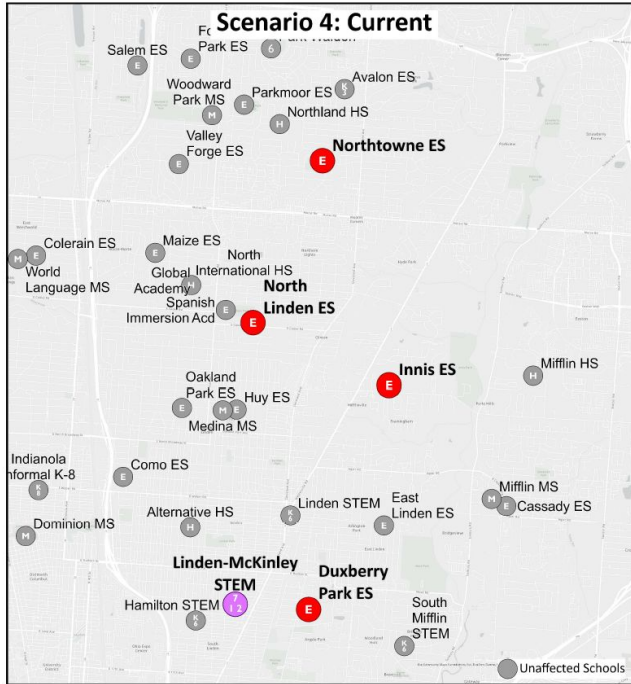

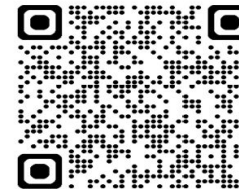
Support for School Closures

Initial Feedback on 4

There have been 13 responses about this scenario.

Side A

Opposition to School Closures

Many respondents are opposed to the proposed school closures in Scenario 4. They express concerns about the capacity of nearby schools, the impact on families and the need for educational supports. They also question the rationale behind the proposal and suggest alternatives such as merging schools or building new facilities on existing properties.

Need for Transparency and Engagement

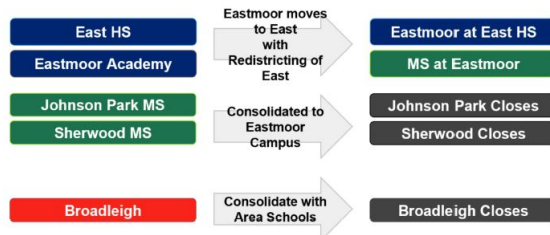
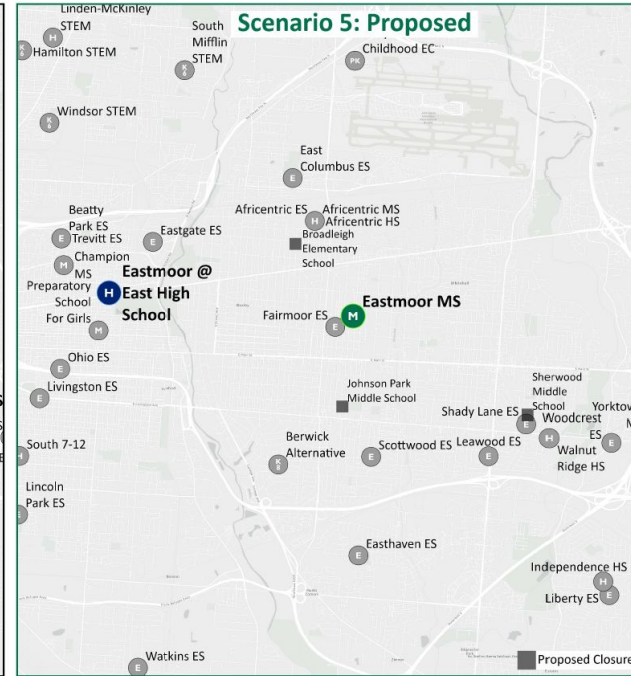
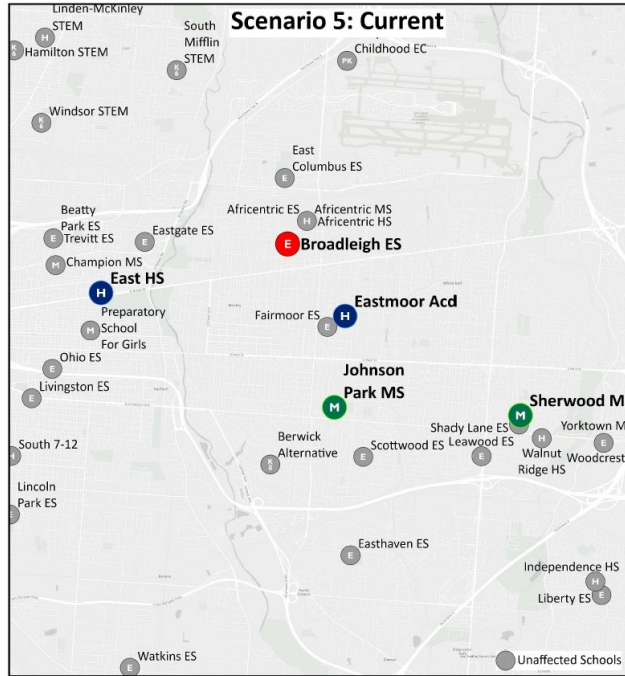

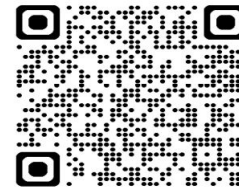
Concerns about Student Welfare

Initial Feedback on 5

There have been 41 responses about this scenario.

Side A

Opposition to Scenario 5

Many respondents expressed opposition to the proposed Scenario 5, citing concerns about transportation, costs, safety, and the potential for conflict between rival schools. They also voiced concerns about the potential loss of legacy and history associated with East High School, and the potential negative impact on the community. Some respondents also questioned the lack of clear information about where current East High School students would go under the proposed scenario.

Concern for Student Well-being

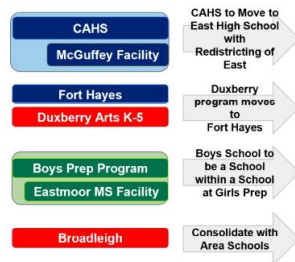
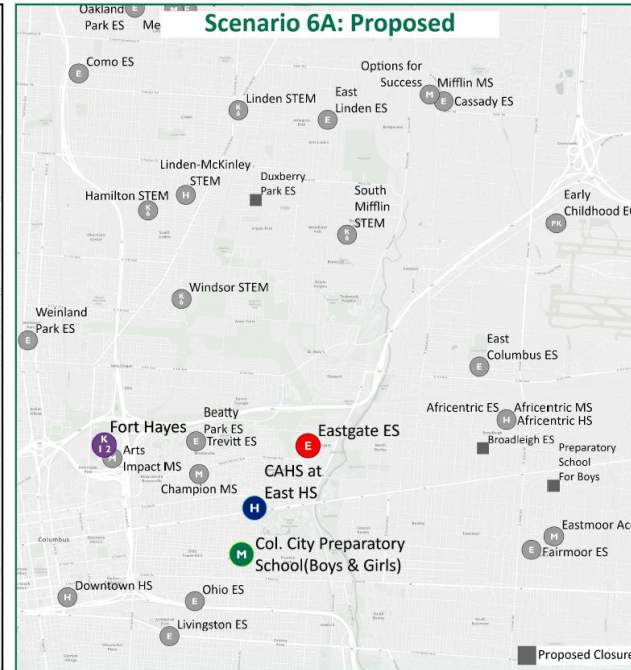
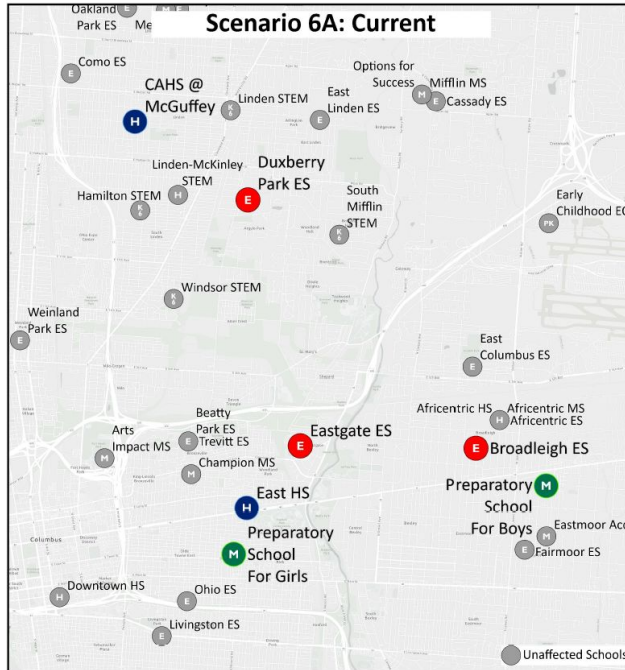

Support for Scenario 5

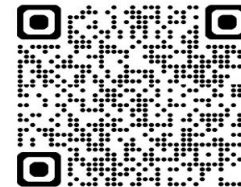

Initial Feedback on 6A

There have been 26 responses about this scenario.

Side A

Opposition to Redistricting

Many respondents express strong opposition to the proposed redistricting of East High School students. They argue that this move is akin to gentrification and sends a negative message to the students, suggesting that they are not valued or deserving of a new building. They also question why East High School is the only one facing redistricting in the proposed scenarios.

Common ground

Concern for Student Welfare

Despite their differing views on the proposed scenario, both sides share a common concern for the welfare of the students. They want to ensure that the students are given the best possible opportunities for education and personal development, whether that involves keeping them in their current school or moving them to a new location. They also express a desire for more transparency and involvement in the decision-making process.

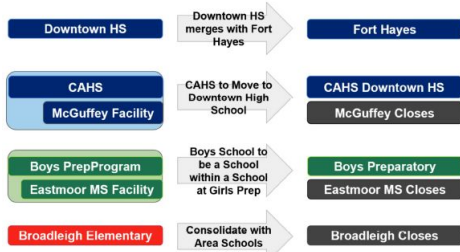
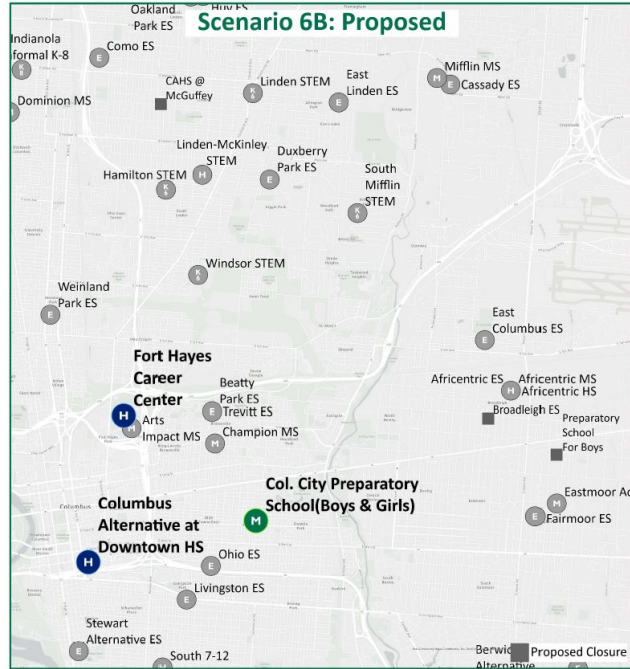
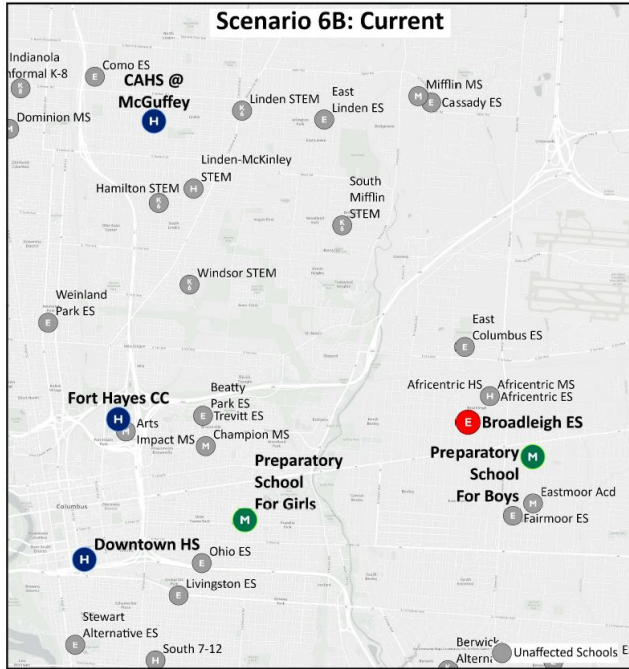

Support for Co-location

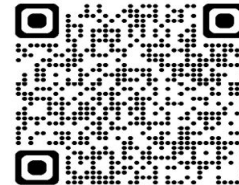

Initial Feedback on 6B

There have been 20 responses about this scenario.

Side A

Support for Scenario 6B

Some respondents are in favor of Scenario 6B, citing the need for a new building for CAHS and the potential benefits of centralizing the school in the city. They believe that the move could provide more opportunities for students across the city to attend CAHS, and that the current building is old and in need of replacement.

Common ground

Need for Improved Facilities

Both sides agree on the need for improved facilities for CAHS. Whether they support or oppose Scenario 6B, respondents agree that the current CAHS building is old and inadequate, and that a new, better-equipped facility is needed.

Side B

Opposition to Scenario 6B

Others oppose Scenario 6B, arguing that it does not provide room for growth at CAHS, does not support the school's broader goals of expansion, and does not offer the necessary facilities for a comprehensive high school experience. They also express concerns about the potential loss of unique programming at Columbus Downtown High School and the impact on students' commute times.
