Annual Report for FY 2022**

ADULT WORKFORCE EDUCATION

Received accreditation approval from the Council on Occupational Education through 2024

Received notification from the Ohio Board of Nursing that all requirements of Chapter 4723-5 of the Ohio Administrative Code were met and maintained by the Columbus School of Practical Nursing

Achieved the Council on Occupational Education (COE) completion, placement, and licensure benchmarks for the Practical Nursing (PN) Program

Administered the PN admissions assessment (HESI) to 120 individuals

Processed the awarding of Pell Grants for Adult Workforce Education students, in the amount of \$315,302

Disbursed \$647,581 in Federal Direct Loan Program funds

Received an 80.6% pass rate on the National Council Licensure Examination for Practical Nurses for 2021

Served 110 and graduated 46 students in the Practical Nurse Program

Submitted all Adult Workforce Education course information to the Ohio Department of Higher Education which generated \$501,075

Received a Center for Training Excellence Grant, in the amount of \$50,000, to develop custom/contract/business services

Met the Ohio Department of Higher Education – Ohio Technical Center Performance Target with an 88.89% Placement Rate for Program Completers

Received Carl D. Perkins funding from the federal Strengthening Career and Technical Education for the 21st Century Act (Perkins V), in the amount of \$120,432, to support Career-Technical and Adult Education

Served 77 students in our ed2go on-line courses which included 35 CCS School Employees

Provided online career training programs for fourteen (14) students in the following areas: Certified Clinical Medical Assistant; Certified Phlebotomy Technician; Certified Residential Interior Designer; Freight Broker/Agent Training; HVAC/R Technician; Residential Electrician; Veterinary Assistant

Received funding from the American Rescue Plan (ARP) Act's Higher Education Emergency Relief Fund the Coronavirus Aid, Relief and Economic Security (CARES) Act to provide direct emergency grants and distributed \$331,906 in 2021 to 83 Practical Nursing students whose lives have been disrupted by COVID-19

ADULT DIPLOMA PROGRAM

Enrolled 28 students in the Adult Diploma Program (ADP)

Awarded an Ohio-issued High School Diploma to 4 graduates who also earned an industry credential

Processed the awarding of sixty-one (61) diplomas for completion of the Ohio 22+ Adult High School Diploma Program

ASPIRE

Received approval for the FY 2023 Aspire Grant Applications (Ohio Adult Workforce Readiness Education - \$1,090,000 & Integrated English Literacy and Civics Education - \$75,000)

Issued 264 General Educational Development (GED) test vouchers, which equal a \$21,120 savings to GED test takers

Enabled 12 individuals to acquire their GED

Registered 421 Aspire students in Distance Education classes

Enrolled 982 individuals in the Aspire Program (333 - Adult Basic Education/Adult Secondary Education and 649 - English for Speakers of Other Languages)

Held a High School Diploma Graduation Ceremony for 66 graduates
