### **Question 1: Poetry Analysis** 6 points

In the following poem by Ralph Waldo Emerson (published in 1867), the speaker reflects on the process of growing older. Read the poem carefully. Then, in a well-written essay, analyze how Emerson uses uses poetic elements and techniques to convey the speaker's complex perspective on aging.

In your response you should do the following:

- Respond to the prompt with a thesis that presents a defensible interpretation.
- Select and use evidence to support your line of reasoning.
- Explain how the evidence supports your line of reasoning.
- Use appropriate grammar and punctuation in communicating your argument.
