# CONGRATULATIONS! Columbus Africentric Early College E S. for receiving \$200,000.00 for the 21st Century Community Learning Center (21st CCLC) program

The Ohio Department of Education announced the grantees awarded federal funding for the 21st Century Community Learning Center (21st CCLC) program. The program creates or expands community learning centers that provide academic enrichment and youth development opportunities for students who attend predominantly high-poverty and low-performing schools. Thirty-four new award recipients were selected from more than 244 applications through a comprehensive peer review process. Priority was given to programs that serve students in rural schools. In addition 185 grantees received continuation funding based on prior year grant awards. The Department awarded \$43,312,638.30 in new and continuing CCLC grants for Fiscal Year 2020.

# Do's and Don'ts

- 1. Do consider circumstances when student is erroneously identified as EL— the LEA should determine how to proceed based on individual circumstances.
- 2. Don't lobby Congress or state legislatures with Title I funds—Title I cannot pay for political activity. It is not an allowable cost under 2 CFR 200.450.
- Don't abuse new flexibility of supplement, not supplant—LEAs comply by showing that they allocate state and local funding on a "neutral" basis, irrespective of a school's Title I status. In a targeted assistance school, funds can only be used to serve students who are failing or at risk of failing the state's challenging academic standards ESEA Section 1115 (a).

# **News to Use**

## Remember when applying for a grant...

Make sure your goals match those of the funding source. Organize your thoughts prior to writing your proposal because the competition will be fierce!

#### Get to know your potential funder

Before you apply for a grant, make sure you know everything you can about the grant maker you are applying to. **Tip:** The Foundation Center is a great resource, but you can also do a Google search.

#### Stick to the grant maker's guidelines

The worst thing would be to pour hours and hours into drafting a proposal, only to have it rejected because you missed the deadline or didn't read the part that said they wanted three copies signed in blue ink.

Tip: Make sure to stick to those guidelines.

#### Speak to your mutual interests

Respond to the issues that are important to the funder. Make it clear and easy to digest.

**Tip:** Even if you think the connection is obvious, the funder will appreciate your understanding their priorities

#### Proofread, proofread, proofread!

Be sure to check your proposal carefully for grammar, spelling, and content as well as whether you have stuck to all the guidelines.

**Tip:** You don't want to be the guy whose proposal was rejected because you didn't use the correct font. Re-Read the grant guidelines.
