Do's and Don'ts

Do translate vital written documents for EL parents, but be wary of supplanting rules—Districts must notify parents of free translation and interpretation services to ensure they are aware of language assistance that ensures meaningful access to districtwide programs and services.

Vital documents that should be translated include those related to disciplinary actions, special education, academic performance, public notifications, field trip permission trips, privacy policies, health service registration forms, class schedules, school bus schedules, emergency notification forms, parent handbooks, fact sheets, notices of parent-teacher conferences and other important documents.

Don't stop EL services before meeting exit criteria— English learners at the highest levels of English language proficiency should continue to receive EL services until they meet criteria to exit from EL status. Exit criteria must include a valid and reliable ELP assessment of all four language domains- listening, speaking, reading, and writing.

News to Use

Process for Grant Funded Requisitions

For all grant funded requisitions, with the exception of open POs, must have a quote attached. A quote must have the following:

- 1. Dates of services
- 2. Location of activity
- 3. School(s) and/or department
- 4. Full description of program, service, and/or activity that explains what is being provided
- 5. Print on P.O. note number 3668 in requisition entry (see attached instructions).

If there is an open P.O., we must verify with the department/ school items being ordered. If a list is not provided, anything deemed unallowable on the grant must be returned or moved to non-grant fund, i.e. general fund. In addition, if the P.O. is between \$10,000 and \$24,999 schools/departments must keep on file three quotes of the services/activity in the building. If over \$25,000, it must be boarded and follow the bidding process if applicable.

All contracts must go through legal, be approved, and have all appropriate signatures. All statement of work must be approved and have all appropriate signatures. Items must be attached to the requisitions as applicable.

If it is travel, the approval number must be entered on the requisition with supporting information regarding the conference.


ALL computer related equipment must be coded to 644 per the IT department. Exceptions are peripherals i.e. mouse, mousepad, keyboard, headphones etc. Monitors and scanners are not peripherals per IT and must be coded to 644.

Any missing information that should be on the requisition or missing documentation, will be rejected after **August 23, 2019**.


<u>Instructions for Note #3668 on Requisition Entry</u>

After entering all required information on the main page of the requisition, click Accept (green check mark) in the upper left hand corner.

The Detail page will come up. After entering all required information in the Description box, click the Add'l Desc/Notes box



Then click Import in the upper right corner.



Select Note #3668, click Accept (green check mark), then click Return
