### **Music Education Grants**

Sponsored by: D'Addario Music Foundation

**Description:** The D'Addario Music Foundation awards grants and product donations to sustainable music instruction programs in order to improve access to music education. Supported programs include those that bring music back into communities and schools, and gets kids playing as early and as frequently as possible.

Eligibility: Private, Charter, Public, Other

**Deadline(s):** Applications are due March 31 and September 30, annually.

### **Bradley Stoughton Award for Young**

**Sponsored by:** ASM Materials Education Foundation **Description:** The award recognizes an outstanding teacher of materials science, material engineering, design, and processing. ASM members aged 35 or younger may be nominated and must demonstrate ability to impart knowledge and enthusiasm to students. Eligible nominees are US teachers of materials science, materials engineering, design, and processing in kindergarten through grade 12 that are current members. Nominators must request a link to the nomination form.

## **Dollar General Youth Literacy**

### Do's and Don'ts - Students With Disabilities

**Do** take steps to promote anti-bullying culture — Take these steps to improve your school climate.

- Raise awareness about bullying. Teach all students what appropriate behavior looks like and how to treat others with respect. Train them to appreciate others' differences.
- Make staff members visible. Increase adult supervision in spaces where there is less structure during the school day, such as the cafeteria, gym, and playground. There should always be somebody close by who can keep an eye on what's going on and intervene if necessary.
- 3. Train teachers to emphasize proper social skills. Instruct them to promote good behavior on an ongoing basis.

**Don't** use Title I to provide required special ed, EL services— In a Title I targeted assistance program, Title I funds may only be used to provide supplemental instruction to students identified as most at risk of failing to meet academic standards.

Students with disabilities or who are English learners may certainly be included in a targeted assistance school's Title I program. BUT schools must be sure to not use the Title I program to provide the services those students are entitled to under the IDEA or other federal, state, or local programs.

**Do** include ELs, students with disabilities in your teacher equity plans An ambitious definition of 'equitable access' that reflects the fact that certain subgroups of students—including English learners and students with disabilities—have been historically underserved. As a result, they may need greater access to excellent educators than their peers in order to get and remain on track to graduate from high school ready for college or careers.

**Don't** skip spending Title I funds to increase student access to STEM materials, equipment - Example: LEAs may use IDEA Part B funds to provide assistive technology devices to students with disabilities so that they may participate in STEM courses.

And district may also use Title III, Part A funds to improve instruction for English learners by acquiring supplemental digital learning resources and software that enable them to better access STEM content, including materials in languages other than English.
