Dollar General Youth Literacy

Description: Youth Literacy Grants

- Purchasing new technology or equipment to support literacy initiatives

• Purchasing books, materials or software for literacy programs **Requirements:** Target Pre-K—12th grade students who are new readers; Target below grade level readers; Assist readers with learning disabilities

Do's and Don'ts - Students With Disabilities

Do communicate core rights of homeless children, youths - Enroll immediately in school; participate fully in school activities; remain in their school of origin; dispute school enrollment decisions; have transportation to and from their school of origin; and access to school programs and services. Children and youths experiencing homelessness also have the right to privacy.

Don't neglect homeless youths with collegiate aspirations - Local homeless liaisons, administrators, counselors and others who serve homeless youths are encouraged to pursue way to remove barriers to their college attainment. So for them the National Association for the Education of Homeless Children and Youth has a toolkit: *College Access and Success for Students Experiencing Homelessness: A Toolkit for Educators and Service Providers.* The toolkit includes information on understanding homeless students. Second, it covers assisting students in choosing a school. Students also may need help in paying or waiving exam and application fees as well as finding financial aid and scholarships.
