Project Lead the Way

Project Lead The Way (PLTW) provides a comprehensive approach to science, technology, engineering, and mathematics (STEM) education through an activity-, project-, and problembased curriculum for students and rigorous teacher professional development model.

The grant process invites schools to submit one general application per PLTW program to be considered for any grant for which an applicant qualifies based on state or program status (i.e. new program or expansion. Complete applications must be submitted using the online system. Schools are encouraged to submit applications in the fall semester to be considered for as many funding opportunities as possible. Most grants are awarded at the end of the fall semester and early in the spring semester

Award(s): Awards vary

Deadlines (Applications are accepted on a rolling basis from July 1 through June 30, annually.

Focus: Engineering, Professional Development, STEM/STEAM/STREAM, Technology Education/Computer Science, Technology Equipment/Devices

Grade Levels: PreK-12, Adult

DOS AND DON'TS -

TITLE II PROFESSIONAL DEVELOPMENT

Do use Title II, Part A to support early child hood education - ESSA provides new opportunities to use Title II, Part A to support early childhood education. Examples:

- Professional development on measuring academic progress of early learners
- Joint professional learning and planning activities to support early childhood educators, teachers, principals, and other professional to meet the needs of children through the age of 8.
- Support for the identification of gifted and talented learners.
- Support for the transition from preschool to elementary school, including issues related to school readiness.

Do use Title II, Part A for mentors, professional induction - Starting a new career as a teacher can be daunting. Every rookie can benefit from a mentor. Title II, Part A supports the retention of talented and effective teachers, including the support of a mentor. Funds may be used to support a mentoring and induction program by providing early release time for mentoring,

Do include early childhood education workers in professional development - Where practicable, provide professional development jointly for school staff and other early childhood education program providers to address the transition to elementary school, including issues related to school readiness. ESEA Section 1119(b)(4) states that LEA and early childhood groups should discuss "organizing and participating in joint transition-related training of school staff, Head Start program staff, and where appropriate, other early childhood education program staff.

Don't forget Title II funding for chronic absenteeism - Title I, Part A, which supports the disadvantaged, and Title IV Part A which supports safe and healthy students, might seem like obvious sources of funding for chronic absenteeism, but don't forget Title II, either. If there are school wide issues with chronic absenteeism or particular issues where additional staff training would help, Title II dollars could be used. ESSA favors professional development that is collaborative and sustained throughout the school year, and not as a one-off or stand-alone workshop.

Does your school do enough to support the socialemotional growth of educators as well as students?
