#### **NEW GRANT OPPORTUNITIES**

#### OSMO for Schools

Beginning <u>July 1</u>, 2021, public schools will be eligible to apply for one of <u>20 mini-grants</u> designed to promote STEAM education.

<u>Osmo for Schools</u> and <u>Osmo Cares</u>, the philanthropic arm of <u>Osmo</u>, will offer \$2,000 in Osmo for Schools products, which include a range of STEAM education kits for classrooms, to 20 schools. The kits are designed for early learning and elementary classrooms and support iPad and/or Fire tablets. (The tablets are not included as part of the grant.)

The application period will run July 1–17, 2021. Winners will be announced in August 2021. Further details can be found at <u>schools.playosmo.com/grants</u>.

#### The Nora Roberts Foundation

The primary focus of the Nora Roberts Foundation is to support Literacy. Additional areas of focus are: Children's programs, Arts organizations, and Humanitarian efforts, with local organizations being its priority. All organizations supported must be a registered 501(c)(3).

Our average grant is \$5000. For first time grant seekers, we recommend asking for \$2,500-\$7,500. You can also ask for less than \$2,500.

#### Preparation of Special Education, Early Intervention, and Related Services Leadership Personnel Grants

**Funding Uses:** The purposes of this US Department of Education program are help address State-identified needs for personnel preparation in special education, early intervention, related services, and regular education to work with children with disabilities; and ensure that those personnel have the necessary skills and knowledge to be successful in serving those children.

Deadline: June 7, 2021

Available Amount: Maximum of \$750,000 per year for a period of up to 5 years

#### DOS AND DON'TS - TITLE IV

#### **Don't** 'geek out' on gadgets with Title IV, Part A

Remember, the third content category for Title IV, Part A grants is called "The Effective Use of Technology," and not simply "Technology."

The grant is more about making better use of technology in the classroom rather than simply acquiring more gadgets or improving the infrastructure, like upgrading the internet connection.

A special rule limits spending on technology and infrastructure to 15 percent of the Effective Use of Technology budget, according to Elementary and Secondary Education Act Section 4109(b).

Technology and infrastructure may include devices, equipment software applications, platforms, digital instructional resources, and/or other one-time IT purchases.

The grant puts more emphasis on academic achievement and digital literacy of all students.

This may include:

- Personalizing learning to improve student academic achievement
- Discovering, adapting, and sharing relevant high-quality educational resources.
- Using technology effectively in the classroom, including by administering computer-based assessments and blended learning strategies.
- Implementing and supporting school– and districtwide approaches for using technology to inform instruction, support teacher collaboration, and personalize learning.

If these academic projects require some professional development, it is important to note that the professional development should not be a one-off, "stand-alone workshop" but something more sustained and job-embedded, perhaps as an intentional part of a school improvement strategy, as ESEA Section 8101 (42) now defines professional development under the Every Student Succeeds Act, Pub. L. No. 114-95.

# **Do** get parents' written consent before performing mental health screening

Shootings have highlighted the need for mental health services

A timely reminder for schools using Title IV, Part A, 21st Century Schools Student Support and Academic Enrichment grants to provide mental health services: Obtain the parent's informed, written consent before performing a mental health screening or another service on a student younger than 18. Elementary and Secondary Education Act Section 4001(a)(1)(A).

Schools should inform parents of the purpose of the assessment, the provider of the assessment, when it will begin, and how long it will last.

Some exceptions are made n the case of an emergency, or when a parent's consent cannot be "reasonably obtained," and for

# 8 Lessons Learned from Remote and Hybrid Learning

- 1. Adjust your expectations about how much content you'll cover and how quickly.
- Don't try to recreate your in-person lessons over Zoom. Try a new approach if you feel stuck.
- 3. Use collaborative, digital workspaces to better understand student thinking.
- 4. Give explicit instructions and stick to routines.
- 5. To get kids talking, try smaller group ins, or one-on-one conversations.
- 6. Craft an intentional, inclusive camera policy for synchronous learning.
- 7. Give students more time than usual to talk about what's going on in the world, share their feelings, or just vent.
- 8. Celebrate the new skills students are learning.
