Enrichment focus areas include affordable housing, community and public safety, arts and culture, youth enrichment and volunteerism.

Entrepreneurship

The Foundation is specifically interested in programs that teach practical economic principles, the benefits of a free enterprise system, and real-world business skills to youth. In addition to supporting educational programs for youth, the Foundation also support organizations that build capacity in small, minority, and women-owned businesses. Entrepreneurship focus areas include youth entrepreneur education and women and minority entrepreneur programs.
