

More Important News

Student Safety and Dismissal Procedures

It is imperative that all drivers *move slowly* throughout the drive in front of the school and on the streets near the school to ensure safety for all. The pedestrians must be safe at all times. We also ask that you stand on the grass behind the flagpole or on the sides if you are picking up your child. Do not ask your child to run to you without the teacher seeing and acknowledging you as the receiving parent. We are working to make our dismissal as safe as possible and appreciate your understanding. It is so important for students to follow all procedures, including safe exit from the building, safe car entry and safe crossing. Thank you for doing your part to keep each student safe during drop off and dismissal.

Likewise, to keep all students safe, it is imperative that you sign into the office and have a visitor's pass if you wish to have access to the school building.

Students <u>will not be called out of their classroom after 3:00</u> <u>pm</u> unless it is an emergency. This situation is very disruptive to the teacher and students as they are trying to end their day.

Parents Right to Know

Cedarwood Elementary is a Title I school. Parents may request information regarding the professional qualifications of their child's classroom teachers, including the following:

- Whether the teacher has met State qualification and licensing criteria for the grade levels and subject areas taught;
- Whether the teacher is teaching under emergency or provisional status through which State qualifications or licensing criteria are waived;
- Whether the teacher is teaching in the field of discipline of the certification or degree; and
- Whether the student is provided services by paraprofessionals and, if so, their qualifications.

In addition, parents may request:

- information on the level of achievement and academic growth of their child on each of the state academic assessments required; and
- timely notice that the student has been assigned or has been taught for 4 or more consecutive weeks by a teacher who does not meet applicable State certifications or licensure requirements as the grade level and subject area in which the teacher has been assigned.

Goal Setting

We are working as a school to become **Cedarwood Woodchuck Leaders** and goal setting is an important component. Your child should be able to tell you what his/her academic and behavioral goals are in the classroom.

Our school goal is *improved academic achievement for all students*. Our focus is on helping students master the state standards through small group instruction, blended learning and formative assessment.



Ohio's Third Grade Reading Guarantee

Ohio's Third Grade Reading Guarantee (3GRG) directs schools to identify which students in kindergarten through grade three are having trouble reading and give students extra reading help to get students caught up in reading as soon as possible. Studies show that children behind in reading at the end of grade three will have a hard time in all subjects in fourth grade and beyond. After that, it can be hard for a child to ever catch up in school.

Under 3GRG, Cedarwood Elementary School will determine the reading needs for each child in kindergarten through grade three at the start of the year. We will then create an improvement plan for each child who is not on track. Teachers will monitor your child's reading and provide intervention throughout the school year. Reading Improvement and Monitoring Plans (RIMP) will be sent home to students who are not on track.

<u>Please note that third grade students who do not meet the assessment requirements for the Third Grade Reading Guarantee will be retained and will NOT be promoted to fourth grade.</u>

There are special rules about the guarantee that can help children who are still learning English and children who have disabilities. Read more about the Third Grade Reading Guarantee at <u>education.ohio.gov</u>, or talk with your child's teacher.
