Metrics of Student Outcomes

If a Final Holistic Rating of Skilled or Accomplished is obtained, the school counselor must receive a rating of Skilled or higher on the metrics of student outcomes to be eligible to be placed on the Skilled or Accomplished Evaluation Cycle the following year.

Final Holistic Rating

¹ School counselors with a previous final holistic rating of Accomplished develop a self-directed Professional Growth Plan. School counselors with a previous final holistic rating of Skilled develop a Professional Growth Plan collaboratively with the evaluator. School counselors with a previous final holistic rating of Developing develop a Professional Growth Plan guided by their evaluator. School counselors with a previous final holistic rating of Ineffective will have an improvement plan created by their evaluator. The school counselor and evaluator should collaboratively pre-determine metrics of student outcomes they will use for that portion of the evaluation rubric at the beginning of the evaluation cycle when discussing the Professional Growth Plan or Improvement Plan.

² The Professional Growth/Improvement Plan Conference may be combined with the Semester 1 Pre-Conference or an Accomplished/Skilled Cycle conference during the same meeting, but all appropriate documentation must be completed for each separately.

³ Walkthroughs can occur at any point during the cycle (provided the Professional Growth Plan has been developed).

⁴ The Semester 1 Post-Conference may be combined with the Semester 2 Pre-Conference during the same meeting, but all appropriate documentation must be completed for each separately.

⁵ Evaluator and school counselor discuss Final Holistic. School counselor receives copy of Final Holistic Form.

⁶ Although only one conference is required, Professional Growth Plans/Metrics of Student Outcomes are to be reviewed regularly to check progress and to have collaborative conversations to strengthen practice. Thus, several conferences should take place throughout the school year.

Documentation must be submitted in OhioES prior to next interaction and within seven school days of occurrence.
